

# Texas PRIMA

## RISK MANAGEMENT ACHIEVEMENT AWARD

### PURPOSE:

This award, sponsored by Texas PRIMA, recognizes a project, program or product that contributes to successful risk management programs and provides an opportunity to share these accomplishments and promote value to other public entities.

### THE AWARD:

- The Risk Management Achievement Awards will be presented during Texas PRIMA's Annual Conference.
- Notification of the award will be sent to recipient's supervisors.
- Recipients will receive a wall plaque.
- Recipients will be recognized in the Texas PRIMA newsletter, *Texas PRIMA Press*.
- Recipients will be recognized on the Texas PRIMA website and social media platforms.
- Recipients will have the opportunity to present the project, program or product to Texas PRIMA membership.

### ELIGIBILITY CRITERIA:

- The Achievement Awards program is open only to current Texas PRIMA public entity members and must be submitted by an active entity's member.
- Only one entry per entity may be submitted annually. Entry should not yet have received industry recognition.
- The project, program or product must be current and meet at least one or more of the following initiatives:
  1. Successfully address a current risk management issue faced by your organization;
  2. Implementation of the new risk management project, program or product which is being nominated within your organization;
  3. Reflects an innovative approach recently implemented by your organization; or
  4. Shows cost effectiveness and/or cost savings for your organization.
- Recipients must be willing to present awarded program via webinar or online article.
- Current Texas PRIMA board members are not eligible to accept this Award.

### SUGGESTED FORMAT:

- The Narrative component of your nomination should include a brief explanation (1000 words or less) that describes the project, program or product and supporting documentation addressing how it meets one or more of the criteria above.
- Your nomination may use any form of organized communication media (including photographs and videos) and should rely on visual presentation where applicable.
- If you submit examples of signage, it should be displayed in a format that can be exhibited at the Texas PRIMA Annual Conference.

### SELECTION PROCESS:

- A panel of risk management professionals led by the Awards Committee, and including previous award recipients, will judge the nominations.
- The panel will judge the nominations based on the above eligibility criteria and applicability for implementation by other entities.
- Selection of award recipients is solely at the panel's discretion based on the information provided by the nominee and known to the panel.
- To protect the integrity of this award, a selection from the submitted nominations may be waived if the panel determines that the criteria for the award has not been met.
- The panel's decision shall be final.
